# The projects to reduce environmental impact:

- The <u>solar photovoltaic</u>, with an installed capacity of about 67 kW and a peak energy produced annually by about 68.000kWh (estimated value), meets from 30 to 40% of total electricity needs and saves about <u>50 Tons</u> of CO<sub>2</sub> environment each year.
- The insulation of office and warehouse properties has saved 33% of primary energy with the reduction of about 20 tons of CO₂ into the atmosphere each year..
- The <u>3R</u> project which was implemented after careful analysis of the processes can allocate most of the waste reduction program, Recycling and Reuse in collaboration with the local authority municipalization.
- The <u>ZeroCarta</u> program (Digitization of internal documents) and the <u>e-</u>
  <u>Workshop</u> (production online tracking system) have greatly reduced the consumption of printing paper thus reducing forest depletion.
- The attention to maintenance, monitoring and control of equipment and facilities allowed to control air emissions and to reduce accidental damage to the environment.


